And whereas, the Parties seek to collaborate with each other to mutually complement their synergies and to jointly work on building capacity of learners through one or more of the programs managed by CDF.


Now therefore, this **Memorandum of Understanding** (hereinafter called "**MOU**") witnesses the following.

- 1. Term and termination:** This MOU is valid for an initial term of 1 year from the Effective Date. It can be extended by further periods, as agreed to by the Parties from time to time. Either Party may terminate this MOU by giving the other minimum 30 days' notice. The MOU will be deemed terminated at the end of the notice period or after completing all ongoing activities so that the beneficiaries (learners and teachers) are not negatively impacted, whichever is later.
- 2. Non-binding nature of this MOU:** The MOU is not binding on either Party and each is working with the other out of sheer good-will and for the benefit of the learners.
- 3. Single Point of Contact (SPOC) for program co-ordination:** Both the Parties shall appoint a suitable person who will serve as a single of contact on all matters related to program rollout. Individual learners and teachers may be in touch with corresponding trainers, mentors, advisors and peers during program rollout but all matters related to the execution of this MOU shall reside with the SPOC.
- 4. Program Calendar:** The SPOCs from both Parties will work with their respective internal stakeholders to develop a calendar for the program(s) rollout at the start of every quarter. This calendar will then be synchronized and published for use by everyone.
- 5. Responsibilities of CDF and/or its program sponsors/partners:**
 - a. Orientation sessions:** CDF will conduct orientation sessions for learners and educators, at a mutually agreed schedule, to onboard them onto the program(s).
 - b. Program materials:** CDF will share all program materials with the institution and/or learners as required. All sharing will be online and/or through electronic media.

- c. **Online instructor led sessions:** These sessions may take the form of webinars or mentoring workshops or technology bootcamps that will seek to assist learners in their career goals. These programs will be organized regular as per a regular calendar, published online and will be conducted by CDF team members or program sponsors or external stakeholders as appropriate.
 - d. **Interaction with Industry experts:** CDF will bring industry experts (as per availability) to the Institute to drive engagements with students through seminars/webinars or project mentorship.
 - e. **Online platform availability:** Online platforms for each of the programs of interest to the Institution will be made available to it. Links for these platforms will be made available to the Institution in a timely manner.
 - f. **Assessments:** CDF will conduct assessments, as required, for its programs prior to certification by CDF and/or its industry partners and/or participating government agencies.
 - g. **Updates:** CDF will keep Institution management updated with the progress of the program(s).
6. **Responsibilities of Institution:**
- a. **Learner identification:** Institute will identify learners, volunteers and instructors who may participate in one or more programs offered by CDF.
 - b. **Support with orientation sessions:** Institute will support CDF conduct orientation sessions for all stakeholders.
 - c. **Support with attendance:** Institute will ensure that program participants enthusiastically participate in chosen programs, with minimum attendance as agreed between the Parties.
 - d. **Support with assessments:** Institute will ensure that assessments carried onsite are proctored and professionally managed.
 - e. **No fees:** Institute will not charge any extra fees from learners for participation in CDF programs. CDF will not charge any fees from the students/university for the program.

PURPOSE

The purpose of this MOU between two parties is to enhance industry institute interaction for mutual benefits in the field of Robotics and Automation.

PREAMBLE

Whereas, Department of Mechanical Engineering, (MECH-PVPIT), bavdhan, pune 21. The Department was established in the year 2006 and offers undergraduate program (B.E.) in Mechanical Engineering with intake capacity of 300. The department of Mechanical Engineering strives to train students in mechanical engineering science as well as application of these scientific methods to conceive, organize & carry out scientific design of engineering system.

Whereas, M/s ROBOTICS DNA Engineering, (ISO 9000 Certified Company) is engaged in Designing and Manufacturing of Automatic Robots.

SCOPE AND TERMS OF INTERACTIONS

Both MECH-PVPIT and ROBOTICS DNA shall encourage interactions between the Engineers, research fellows, faculty members and students of both the organizations through the following arrangements

- a) Exchange of personnel through deputation as per the rules of the respective institute, for limited periods as mutually agreed upon;
- b) Organization of joint conferences and seminars;
- c) Practical training of MECH-PVPIT students at ROBOTICS DNA
- d) Joint guidance of student projects/ internships in bending, sheet metal working, dies development and other areas of specific interest.
- e) ROBOTICS DNA would accommodate BE students who have completed the 5th semester of their program in such a number that ROBOTICS DNA deems convenient to it for the purpose of imparting industrial training
- f) ROBOTICS DNA may depute its personnel as visiting faculty at MECH-PVPIT to teach any of the regular Course or specialized topics.
- g) ROBOTICS DNA may seek assistance/guidance of MECH-PVPIT faculty members in product/process modification, modernization, trouble shooting, etc.
- h) Would allow the industrial visits of students for half/full day to provide them with an exposure to various equipment, instrument, etc.
- i) ROBOTICS DNA may showcase its business activities at the seminar/workshop/conference, etc at MECH-PVPIT
- j) Post-graduate students will be allotted a Research supervisor from MECH-PVPIT faculty members. An Engineer at ROBOTICS DNA may be appointed a Co-research guide as per the rules of the respective institute for a student Registered for BE/ME degree at MECH-PVPIT The student may be encouraged to take up the project such that ROBOTICS DNA desirably benefits from its outcomes
- k) The students will carry out part of their BE/ME project at MECH-PVPIT and ROBOTICS DNA- depending on the nature of the work as per rules of the respective institute depending on facilities and requirements
- l) There will be no restriction on the contents of the thesis and on publication of results of the thesis, subject to the condition that no Intellectual Property Rights can be secured for any part of the work which will be decided with mutual consent

- m) Both MECH-PVPIT and ROBOTICS DNA will be free to independently carry out follow-up research on the thesis work conducted under this scheme.
- n) Neither of the supervisors will publish the work carried out under this MoU without knowledge of the other
- o) In any of the activities mentioned above, wherever financial aspects are involved, amount, payment conditions, etc would be spelt out clearly before starting the activity.

Intend to form a nucleus for promoting excellent quality manpower in the fields of engineering, technology, and sciences with special emphasis on manufacturing and cost saving.

Now, therefore, in consideration of the mutual promises made herein and of good and valuable consideration, the receipt and sufficiency of which both MECH-PVPIT and PEPL hereby acknowledge, MECH-PVPIT and ROBOTICS DNA hereby agree to sign a memorandum of understanding (MOU)

CONFIDENTIALITY

- a) During the tenure of the MOU both MECH-PVPIT and ROBOTICS DNA will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MOU for any purpose other than in accordance with this MOU
- b) Both MECH-PVPIT and ROBOTICS DNA shall bind their respective personnel who come into possession or knowledge of any confidential information not to disclose the same to third parties without the written approval of the disclosing party or use such confidential information for any use other than intended under this agreement or projects.
- c) Further both MECH-PVPIT and ROBOTICS DNA shall put in place adequate and reasonable measures to keep and store confidential information secure so as to prevent any unauthorized use.

CONFIDENTIAL INFORMATION

However confidential information shall not include any data or information which:

- a) is or becomes publicly available through no fault of the receiving party

- b) is already in the rightful possession of the receiving party prior to its receipt of such data or information,
- c) is independently developed by the receiving party without reference to the confidential information of the disclosing party
- d) is rightfully obtained by the receiving party from a third party or is in the public domain
- e) is disclosed with the written consent of the party whose information it is, or
- f) is disclosed pursuant to court order or other legal compulsion, after providing prior notice to the disclosing party.

Memorandum of Understanding for the Exchange of Faculty and Students

Between

And

TSSM'S Padmbhushan Vasantdada Patil Institute of Technology (PVPIT) , Bavdhan, Pune

The objective of this Memorandum of Understanding (MOU) is to establish the collaboration between Jayawant Shikshan Prasarak Mandal's, Rajarshi Shahu College of Education, (B.Ed.) Pune and TSSM'S Padmbhushan Vasantdada Patil Institute of Technology (PVPIT) , Bavdhan, Pune for the purpose of a faculty- student exchange agreement.

PARTICIPATING PARTIES

- I. Faculty and Students of Jayawant Shikshan Prasarak Mandal's, Rajarshi Shahu College of Education, (B.Ed.), Pune
- II. Faculty and Students of TSSM'S Padmbhushan Vasantdada Patil Institute of Technology (PVPIT) , Bavdhan, Pune , Terms of the MoU

TERMS OF MOU, GENERAL REGULATIONS, ELIGIBILITY AND ENROLMENT

1. The two parties agree to enter into a student exchange agreement, commencing in the academic year 2019-2024
2. The participating students and faculty will register at the host institution for the full academic year or for a minimum of one academic term.
3. Each institution may send up to 05 students and 02 faculty per academic year to participate in the exchange. The number of participants may be increased subject to the mutual agreement of both institutes.
4. It is expected that in any given year there will be an equal number of students exchanged from each institution. The number of faculty also equal for the faculty exchange program.
5. Not with standing Clauses 3 and 4 above, while equal numbers in every year may not be possible, efforts will be made to have equal numbers exchanged over a five-year period.
6. The participant will be students who are completing an undergraduate program or graduate program at their respective institutions.

7. The participants will be selected by their respective institutions to participate in the exchange. Candidates must satisfy admission requirements for special student status, including language proficiency requirements, of the host institution or the host department.
8. Participants in the faculty exchange will be required to have completed at least one year of teaching experience prior to participation in the exchange. Participating graduate students should have completed at least one term of studies at the home institutes.
9. Each institution will appoint an individual to act as the coordinator for the exchange. The exchange is coordinated in both institutes through coordinator.
10. The host institutions will have the right of refusal of any candidate who may appear to be unacceptable for the exchange.

RESOURCES AND REGULATIONS AT THE HOST INSTITUTION

11. The topic as per the curriculum and class and time-table for the faculty and student exchange program will be decided by the host institute by making coordination with other institution.
12. At the end of the academic year, the participants in the exchange will request the host institution to send to the home institution a report/official transcript of their academic achievement.
13. Each participant in the exchange must ensure that they have adequate health and accident insurance coverage.
14. Exchange students are subject to the rules and regulations of the host institution. The host institution reserves the right to dismiss any participating student at any time for academic or personal misconduct. The dismissal of a participant shall not abrogate the agreement for the arrangements regarding other participants.
15. Both the institutes will share their library resources

DURATION, AMENDMENT AND TERMINATION OF THIS AGREEMENT

16. The parties will review the terms of the MOU annually to assess the success of the exchange, and will determine whether to continue, modify or discontinue the MOU. Each party reserves the right to terminate this MOU upon six months written notice to the other. Any exchanges of students taking place at the time of termination will not be affected; exchange students who already stay at the host institution will be allowed to complete the exchange program.
17. This MOU shall take effect when signed by both parties, and will remain in effect for period of five years. Thereafter, it has to be renewed for another period.



- 9.1 All Confidential Information, including the inherent intellectual properties, remains the sole and exclusive property of the Disclosing Party and Recipient shall not right, title or interest in the same. Similarly, the Disclosing Party does not own any of the intellectual property of the Recipient, including any proprietary methodologies, tools, or practices, unless otherwise agreed.
- 9.2 The Disclosing Party, unless expressly confirmed, makes no warranty regarding the accuracy or reliability of Confidential Information.

10. Important Points –

- 10.1 Notwithstanding any other provision of this MoU, neither party shall have any right to use any trademarks or trade name of other party nor to refer this MoU or the obligations performed hereunder directly or indirectly, in connection with any product, promotion or publication without the prior written approval of the other party.
- 10.2 The terms and conditions mentioned herein shall commence on the execution of this MoU and shall continue for a period of two (2) years from the date thereof or such period as may be determined or extended by the parties from time to time by written notice, unless terminated by either party in accordance with this MoU. Either party may terminate this MoU At any time by providing two (2) months' notice to the other party.

- 10.3 Any notice required to be given hereunder shall be in writing and shall be deemed to be sufficiently served on the party if sent by hand or by registered post to the addresses of the party as stated in this MoU. Notices shall be deemed received; -
- If sent by registered mail, (20 days after posting)
 - If by hand on the day of delivery; and
 - If sent to the correct number or designated address within seventy-two (72) working hours.

If the other party fails to appoint his Arbitrator within specified time of 7 days of receiving such notice than the appointed Arbitrator of that party shall be sole Arbitrator and shall have all powers to arbitrate as of Tribunal. All Arbitration proceedings for the disputes between the parties shall be in accordance with the provision of The Arbitration and Conciliation Act, 1996. Without prejudice to the aforesaid, the Arbitration Tribunal (as constituted) shall give a reasoned award within 75 days of their appointment. Memorandum of Understanding

This Memorandum of Understanding is entered on 18 November 2022 ("Effective Date") by and between **Edunet Foundation** having its office at A-11- 1105, Arcadia South City 2, Gurgaon 122018, India (hereinafter referred to as "Edunet"); and **TSSM's Padmabhooshan Vasantdada Patil Institute of Technology, Bavdhan, Pune** having its address (hereinafter referred to as "Institution").

Vision:	PVPIT is governed by The Shetkari Shikshan Mandal, a charitable Trust registered under Bombay Public Trust Act 1950 and Societies Registration Act 1860. The TSSM started the Padmabhooshan Vasantdada Patil Institute of Technology in the academic year 2006-07. The College is approved by All India Council for Technical Education (AICTE), New Delhi, recognized by Government of Maharashtra, Directorate of Technical Education (DTE) and affiliated to Savitribai Phule Pune University (SPPU).

Individual learners and teachers may be in touch with corresponding trainers, mentors, advisors and peers during program rollout but all matters related to the execution of this MOU shall reside with the SPOC.

4. Society for Inclusive Education (SIE): This is a student led initiative managed and supported by Edunet, that seeks to provide ubiquitous high quality learning opportunities to underserved communities through government and private schools/colleges around India. The Institute will set up a chapter of Society for Inclusive Education on its campus. This chapter will make Edunet programs available to local underserved institutions and/or student communities through community work, classroom sessions, fund raisers to purchase equipment and

free learning platforms. Office bearers will be chosen by the Institute in the first year.

They may be either nominated or elected second years. The SIE chapter will have members from within the local student community who are willing contribute some time towards betterment of society. All members of SIE chapter at the Institution will be issued with appropriate certification that will help them meet their CAS/Community Work/SUPW requirements.

5. Program Calendar: The SPOCs from both Parties will work with their respective internal stakeholders to develop a calendar for the program(s) rollout at the start of every quarter. This calendar will then be synchronized and published for use by everyone.

6. Responsibilities of Edunet and/or its program sponsors/partners

a. Orientation sessions: Edunet will conduct orientation sessions for learners and educators, at a mutually agreed schedule, to onboard them onto the program(s).

b. Program materials: Edunet will share all program materials with the institution and/or learners as required. All sharing will be online and/or through electronic media.

c. Online instructor led sessions: These sessions may take the form of webinars or mentoring workshops or technology bootcamps or innovation camps or career readiness workshops that will seek to assist learners in their career goals. These programs will be organized regular as per a regular calendar, published online and will be conducted by Edunet team members or program sponsors or external stakeholders as appropriate.

d. Interaction with Industry experts: Edunet will bring industry experts to the Institute to drive engagements with students through seminars/webinars or project mentorship.

e. Online platform availability: Online platforms for each of the programs of interest to the Institution will be made available to it. Links for these platforms will be made available to the Institution in a timely manner.

f. Assessments: Edunet will conduct assessments, as required, for its programs prior to certification by Edunet and/or its industry partners and/or participating government agencies.

g. For programs with career paths: Edunet will provide linkages with local and regional industry, government and the local start-up ecosystem (incubators etc) that will help learners with gainful employment and/or entrepreneurial opportunities. 2. The party (parties) disclosing Confidential Information is(are), both parties.



In the remainder of this Agreement, the term "Disclosing Party" shall mean the party or parties identified in this Article 2, and the term "Receiving Party" shall mean the party to this Agreement receiving the Confidential Information.

In the remainder of this Agreement, the term "Affiliate" shall mean a company or any other corporate entity which directly or indirectly, (i) controls or is controlled by a Party; or (ii) which is controlled by a company or any other corporate entity which controls, directly or indirectly, a Party, where control shall mean the ownership of more than 50% of the capital or the voting shares of the company or entity concerned. Affiliate shall not be construed as a third party in the purpose of this Agreement.

3. "Confidential Information" shall mean all knowledge and information which the Receiving Party may acquire from the Disclosing Party, its employees, consultants, agents, representatives or affiliated companies by whatever means, including but not limited to information regarding: its proprietary products and processes, ingredients, recipes, know-how, business activity, business plans, inventions, designs, methods, systems, improvements, trade secrets, information or data relating to research, development, marketing, finance, customers or purchasing and all other information which may come to the knowledge of the Receiving Party with regard to the business of the Disclosing Party, irrespective of its shape, form or media, and including but not limited to any electronically stored information.

Confidential information shall only include such information which: (a) is clearly designated in writing by the Disclosing Party as "Internal", "Confidential", "Strictly confidential" or the like at the time of disclosure, or (b) is declared confidential by the Disclosing Party at the time of disclosure and confirmed in writing to the Receiving Party within thirty (30) days of the disclosure.

Information disclosed or collected directly or indirectly during a visit at the premises of the Disclosing Party, is considered Confidential Information and does neither have to be marked as confidential nor confirmed in writing as such.

4. The Confidential Information disclosed pursuant to this Agreement includes in particular and without limiting the scope of Confidential Information: (i) information disclosed by PVPIT, Pune relating to [Bobst product design and documents], and (ii) information disclosed by Bobst relating to [Bobst product design and documents].
5. Confidential Information is disclosed for the following purpose (hereinafter "Purpose"): [e.g. "work with students to generate ideas on machine development tasks and to collaborate work experience from Bobst team and an opportunity to hire good talent in the coming days"]. The Receiving Party shall not use the Confidential Information, directly or indirectly, for any other purpose.
6. The Receiving Party agrees that it will hold in confidence all Confidential Information, and to take adequate organizational and technical measures to this purpose. Each party further agrees that it will not advertise, publish or in any way publicly indicate the fact that it is working with the other party for the purposes set out in this Agreement, unless it has received the other party's prior written authorization.

This provision shall survive the expiration of this Agreement permanently.

7. Confidential Information shall be disclosed by the Receiving Party only to those of its employees, consultants, agents, representatives and affiliated companies, if any, who need to know such Confidential Information for the Purpose, who have been informed of the confidential nature of such information, and who are obligated under agreement to keep such information in confidence. The Receiving Party shall be responsible for any breach of confidence caused by the acts or omissions of such employees, consultants, agents, representatives and affiliated companies. The Receiving Party shall maintain complete and accurate records and information to demonstrate its compliance with this clause and allows the Disclosing Party or its designated auditor to perform mutually agreed and specified audits at the costs of the Disclosing Party.
8. The obligations set forth in this Agreement shall not apply to any portion of the Confidential Information which the Receiving Party can prove with contemporaneous written records: (a) was already known to the Receiving Party prior to any disclosure by the Disclosing Party; or (b) was publicly available prior to any disclosure by the Disclosing Party, or subsequently becomes publicly available through no breach of this Agreement; or (c) was received by the Receiving Party from a third party lawfully in possession of the same and not in breach of any agreement or any confidential relationship with the Disclosing Party; or (d) was independently developed by the Receiving Party, its parent or affiliated companies without reliance upon the Confidential Information of the Disclosing Party.
9. The Receiving Party shall have the right to disclose to the relevant authority any Confidential Information which is required to be disclosed pursuant to judicial process, court order or administrative request, provided that the Receiving Party shall notify, where reasonably possible, the Disclosing Party of any such process, order or request sufficiently prior to disclosing such Confidential Information as to permit the other party to seek a protective order.
10. Confidential Information shall remain the property of the Disclosing Party. Nothing in this Agreement will be construed to convey to either party any right, title, or interest in any Confidential Information, and no license is granted or implied by either party to the other under any patent, design, copyright, trademark, data or knowhow, any application for any of the foregoing, or any trade name or trade secret.
11. The parties hereby acknowledge that the information provided under this Agreement is provided as is; and that neither party makes any oral or written representations or warranties, express or implied, as to the accuracy, reliability or completeness of the information provided under this Agreement. Therefore, neither party shall have any liability to the other arising out of or relating to the use of the information provided under this Agreement.
12. The Receiving Party shall, upon request of the Disclosing Party, return to the Disclosing Party all Confidential Information supplied by the Disclosing Party, its employees, consultants, agents, representatives or affiliated companies, including all copies thereof, and make no further use of it.
13. This Agreement comes into effect on the Effective Date specified above and shall remain in effect for five (5) years. Either party may terminate this Agreement at any time and for any reason upon 30 days written notice to the other party. The obligations regarding confidentiality set out in this Agreement remain in effect permanently unless the Receiving Party can demonstrate that the Confidential Information has become publicly available.
14. This Agreement shall not be construed to create any obligation on the part of either party to enter into any further business relationship with the other party.



15. A finding that any provision of this Agreement is invalid or unenforceable will not affect the validity or enforceability of any other provision of this Agreement, unless the provisions that have been found to be invalid or unenforceable substantially affect the rights or obligations granted or undertaken by either party.
16. The failure of a party to insist, in one or more instances, upon performance of any of the provisions or conditions of this Agreement will not be construed as a waiver of any other provision or condition of this Agreement, and no present waiver will be construed as a future waiver of such provision or condition.
17. In case of breach of this Agreement by the Receiving Party, the Disclosing Party is entitled to a contractual penalty in the amount of the turnover between the parties in the calendar year preceding the infringement, or the intended annual turnover between the parties in case there was no turnover in the year preceding the infringement, plus actual damages and interest exceeding the aforementioned penalty.
18. It is understood and agreed that money damages may not in all cases be a sufficient remedy for a breach of this Agreement. The Disclosing Party shall therefore be entitled to (a) injunctive relief or specific performance without proof of actual damage and/or (b) actual damages and interest.
19. No modification of this Agreement shall be effective unless made in writing and signed by a duly authorized representative of each party.
20. This Agreement shall in all respects be governed by and interpreted according to the laws of India.
21. Any dispute under this Agreement which cannot be resolved amicably shall be decided exclusively by the competent courts of India.
22. This Agreement states the entire understanding of the parties regarding the subject matter hereof and supersedes any prior discussions or negotiations concerning this matter.

This Memorandum of Understanding is made on 01/01/2019

Chandni Chowk, Pirangut Road, Bavdhan, Pune, Maharashtra 411021 (hereinafter referred to as "PVPIT", which expression shall, unless repugnant to the context or meaning thereof, include its successors, legal representatives and permitted assignees) on FIRST PART

And

HCL Technologies Ltd , a Company duly organized and existing under the laws of India having its registered office at 806, Siddharth, 96, Nehru Place, New Delhi, Delhi, India (hereafter referred to as "HCL", which expression shall unless repugnant to the context or meaning thereof, include its successors, legal representative and permitted assignees) on SECOND PART

AND WHEREAS, "PVPIT" is among the noteworthy academic institutes of Pune offering UG and PG programs in Mechanical Engineering, Civil Engineering, Electronics and Telecommunication Engineering and Computer Engineering.

AND WHEREAS, HCL is a registered company, engaged in providing services related to the software engineering services, software training and the development, implementation and integration of computer software.

AND WHERE both "PVPIT" and HCL are desirous of associating with each other to expertise students of PVPIT on HCL's proprietary products (DFMPro and Geometric Stack up) as an addition to PVPIT curriculum. HCL will provide academic license of these products to PVPIT ("Course").

Now therefore, in consideration of the premises and the actual covenants herein contained, it is agreed by both PVPIT and HCL as under.

1.0 Definitions and Interpretation

- 1.1 "MOU" shall mean this Memorandum of Understanding executed between PVPIT and HCL on 01-01-2019
- 1.2 "Party" or "Parties" shall mean PVPIT and HCL individually and collectively as the context may require;
- 1.3 The headings/subheadings/titles sub-titles are only for the sake of convenience and shall not be interpreted to restrict or otherwise affect the meaning or import of the clauses, which shall be interpreted solely in light of the contents thereof.
- 1.4 Use of words in the singular includes the plural and vice versa and the masculine gender includes the feminine where applicable.
- 1.5 Where a word or phrase is defined, other parts of speech and grammatical forms of that word or phrase shall have the corresponding meanings. Any reference to

'Writing' includes printing, typing, lithography and other means of reproducing words in visible form.

2.0 The Course

- .1. The course shall be conducted on DFMPPro and Geometric Stackup.
- .2. The course contents mutually agreed may be subject to change as and when necessary and mutually agreed.
- 2.1. The course shall include Software demo, Lab work material, technical information and career guidance from HCL.
- .3. With reference to above point the first three activities i.e. lectures, practical and technical assessment shall be under HCL. The career guidance from HCL shall be part of value added activities from HCL.
- 2.1. This Course will be free of cost for the students of engineering.

3.0 Responsibility Structure

- 3.1 PVPIT shall provide the infrastructure of systems, LCD projector etc.
- 3.2 HCL shall be responsible to provide online support for software demo/training to faculty, academic licenses, course materials and career guidance.
- 3.3 PVPIT shall create awareness amongst its students for promotion of the course.

4.0 Certification

Upon completion of the Course, HCL will conduct technical assessment for students. The students qualifying the technical assessment shall be certified with course completion certificate. Rights to conduct assessment is reserved by HCL.

5.0 Relationship

This MOU relates solely to the intention of the parties, wherein PVPIT and HCL jointly offer a course on "DFMPPro and Geometric Stackup" and shall not extend to any other activity or create a partnership between the Parties hereto and under any law of any country. The parties agree that it is not their intention to share any loss or profit between them in their respective fields, except to the extent expressly provided herein.

6.0 Authority to Bind

No party shall act on behalf of the other party to contractually bind the other Party under the terms of this MOU having first obtained the other Party's written agreement.

7.0 Confidential and Proprietary Information

- 7.1 "Confidential Information" shall mean all information, including the Course material and academic licenses so given to PVPIT, written or verbal, identified as confidential or of a nature that a reasonable person would understand as being considered confidential by HCL, and disclosed by HCL to PVPIT or its faculty which is related to HCL information such as course material, training data, guidance notes, procedures, methodology, etc.
- 7.2 PVPIT shall hold in trust and confidence for HCL all confidential information provided by HCL, and PVPIT shall not disclose to any person or use such information for any purpose other than defined in this MOU. PVPIT shall not make any copies of the confidential information other than are required for the work involved and with prior and mutual consent from HCL and shall return/destroy all such information at the termination of the contract. By disclosing this information to PVPIT, HCL does not grant any expressed, implied or other license or right to PVPIT to propagate the information. HCL hereby grants to PVPIT an academic, non-exclusive, non-transferable right and license solely for the purpose of providing practical training to the PVPIT students.
- 7.3 PVPIT shall not disclose HCL confidential information without first obtaining written consent from HCL.
- 7.4 PVPIT shall disclose HCL confidential information only to PVPIT employees having a legitimate reason to know the same and shall inform each employee receiving the confidential information of the confidential nature of the same and PVPIT obligations hereunder.
- 7.5 PVPIT shall secure documents, items of work in progress and work products that embody confidential information in locked files or areas providing restricted access to prevent its unauthorized disclosure. PVPIT shall maintain adequate procedures to prevent loss of any confidential information or confidential documents provided to it by HCL. In the event of any loss, PVPIT shall notify HCL immediately.

8.0 Termination

1 (one) year from the date of signing of MOU, unless renewed on a mutually agreed terms and condition for a further period. During the initial term or any renewal term, either party may terminate this MOU upon thirty (30) days prior written notice to the other party.

9.0 Assignment

This MOU shall not be assigned or otherwise transferred by any Party, in whole or in part, without the express written consent of the Other Party.

10.0 Consequential Damages

Other than explicitly mentioned in this MOU, either Party shall not under any circumstances or at any time be liable to the other under or in connection with the MOU

for any special or any direct or indirect loss or damage or for any consequential loss or damage, whether direct or indirect, including but without limiting the generality of the foregoing, loss of profits, loss of production, or loss of opportunities.

11.0 Severability

If any provision of this MOU or the application thereof to any person, entity or circumstance shall be invalid or unenforceable to any extent, the remainder of this MOU shall not be affected thereby and the application of such provision shall be enforced to the greatest extent permitted by law.

12.0 Arbitration

12.1 All disputes, differences or claims arising out of or in relation within this MOU not limited but inclusive of as regards to rights, liabilities, damages, claims, breach or interpretation of this MOU between the Parties shall be referred to arbitration.

12.2 Any party shall give a written notice to other party of existing such dispute, difference or claim. On receipt of such notice within 15 days, the Head of Institution of PVPIT and Partner, HCL or any other persons so nominated by the respective Parties, shall meet together and try to resolve such dispute, difference or claim amicably. If such amicable solution is not arrived within one month, then the matter shall be referred to Arbitration.

12.3 The place of arbitration shall be Pune. The arbitration proceedings shall be conducted in English as per the rules of The Arbitration and Conciliation Act 1996 by three (3) arbitrators appointed in accordance with the said Rules. The Arbitration Decision shall be final and binding.

13.0 Governing Law


